

Terms & Conditions:

- Following terms & conditions apply to new customers of BSF ('Bank') for earning up to 1 million BSF Jana points as part of starting their relationship with the Bank during the campaign.
- This offer is also applicable to those customers who reestablish relationship with the Bank by reopening their accounts during the campaign period.
- Customers may open or reopen either the current account or Islamic current account to become eligible for BSF Jana points.
- Qualifying Criteria for Customers Opening their Current Accounts: Customers who establish their relationship by maintaining current account would earn BSF Jana points based on the average balance maintained in the account.
- Customers maintaining an average balance of SAR 500,000 or more in the first 3 months, subsequent to the month in which they opened or reopened their current account, would earn 1% of the value of their average balance in those three months with a maximum of 1,000,000 BSF Jana points which are equivalent to SAR 10,000.
